DESCRIPTION

We will examine the transformation of the Asian countryside from the beginning of the twentieth century up until the present by looking at agrarian class structure, economic and social development, collectivization and decollectivization, rural industrialization, agribusiness, sustainable agriculture, and rural unrest. The course materials combine theoretical readings with empirical case studies. While theoretical readings examine global processes involving Asia and elsewhere, case studies cover several Asian countries, with an emphasis on China and India.

REQUIREMENTS

Class participation: Class participation involves regular class attendance as well as active participation to classroom discussions. Discussing your ideas on course readings with other classmates is the best way to learn the course materials well.

Thought pieces: Each student is required to write five pieces (2 to 3 pages, double spaced). Thought pieces will be graded on a scale of 1 and 4. You may choose any five of the twelve weeks to write a thought piece. Thought pieces must be based on that week's readings and are intended to help you reflect more deeply on the readings and prepare for the seminar discussions. These papers should not be summaries, but rather commentaries on the readings that develop and/or critique arguments, make comparisons between different authors and/or point to larger implications. Each thought piece must engage at least 2 readings of that week. You will receive feedback on all thought pieces. All thought pieces must be uploaded to the Blackboard web page before Sunday 8 pm for each week. Late thought pieces will not be accepted.

Mid Term Paper: Students are required to write one mid-term paper. It will be 5-6 double-spaced pages in length. Mid-term paper will address a question or series of questions that will be given to you by the instructor. You must draw on the readings of this class to write your mid-term paper. You are not required to seek additional sources beyond those covered in class. You will receive your mid-term paper question(s) in class on October 4. I will also put the question(s) on Blackboard. Mid-term papers are due on October 11 (You will upload your papers on Blackboard).

Final Paper: Students are required to write a final term paper on a theme related to the content of this course. They need to submit a single-page outline of their papers before October 18 and meet with the instructor to discuss their outlines before October 30. Each student is required to make a short presentation (no longer than 10 minutes) about her/his final paper on the last two weeks of the class. Final papers should be well organized and carefully proofread. The length of the papers should be 20 (double-spaced) pages minimum and 30 (double-spaced) pages maximum (including References). Any system of citation (AAA, APA, Chicago, etc.) is fine, as long as it is used consistently. Papers must be submitted as Word (not pdf) documents via Blackboard web site. Final papers are due on December 12. Late papers will not be accepted.
